PETILEN H2-21T is a low density polyethylene resin produced by high pressure tubular process. Having medium average molecular weight, the product is developed for general purpose applications. PETILEN H2-21T contains no additives.

Film extrusion: lamination, citrus fruit bags

Recommended Processing Conditions

Blown film extrusion applications;

Typical zone temperatures: 140 - 180°C Typical melt temperature: 160 - 180°C Typical blow-up ratio (BUR): 2:1 - 3:1
